## SECTION 4: First aid measures

### 4.1. Description of first aid measures

<b>General information</b>	Get medical attention if any discomfort continues. Show this Safety Data Sheet to the medical personnel.

## **SECTION 5: Firefighting measures**

### **5.1. Extinguishing media**

**Suitable extinguishing media** Extinguish with alcohol-resistant foam, carbon dioxide, dry powder or water fog. Use fire-extinguishing media suitable for the surrounding fire.

**Unsuitable extinguishing media** Do not use water jet as an extinguisher, as this will spread the fire.

### **5.2. Special hazards arising from the substance or mixture**

**Specific hazards** Containers can burst violently or explode when heated, due to excessive pressure build-up. This product is toxic.

**Hazardous combustion products** Thermal decomposition or combustion products may include the following substances:  
Toxic gases or vapours.  
Vapours are heavier than air and may travel along the floor and accumulate in the bottom of containers.  
Forms explosive mixtures with air on intense heating.

### **5.3. Advice for firefighters**

**Protective actions during firefighting** Avoid breathing fire gases or vapours. Evacuate area. Cool containers exposed to heat with water spray and remove them from the fire area if it can be done without risk. Cool containers exposed to flames with water until well after the fire is out. If a leak or spill has not ignited, use water spray to disperse vapours and protect men stopping the leak. Control run-off water by containing and keeping it out of sewers and watercourses. If risk of water pollution occurs, notify appropriate authorities.

### 7.1. Precautions for safe handling
