4.1. Description of first aid measures

Appropriate engineering controls	Provide adequate general and local exhaust ventilation. Ensure the ventilation system is regularly maintained and tested. Eye/face protection	Wear tight-fitting, chemical splash goggles or face shield. If inhalation hazards exist, a full-face respirator may be required instead.
Hand protection	Wear protective gloves.
