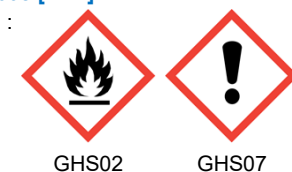

6.1. Personal precautions, protective equipment and emergency procedures
