## SECTION 4: First aid measures

### 4.1. Description of first aid measures

<b>General information</b>	Get medical attention if any discomfort continues. Show this Safety Data Sheet to the medical personnel.
<b>Inhalation</b>	Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. Loosen tight clothing such as collar, tie or belt. Rinse nose and mouth with water. Never give anything by mouth to an unconscious person. Get medical attention if symptoms are severe or persist. In the event of any sensitisation symptoms developing, ensure further exposure is avoided.
<b>Ingestion</b>	Get medical attention immediately. Rinse mouth thoroughly with water. Give a few small glasses of water or milk to drink. Stop if the affected person feels sick as vomiting may be dangerous. Never give anything by mouth to an unconscious person. Place unconscious person on their side in the recovery position and ensure breathing can take place. Keep affected person under observation.
<b>Skin contact</b>	It is important to remove the substance from the skin immediately. In the event of any sensitisation symptoms developing, ensure further exposure is avoided. Remove contamination with soap and water or recognised skin cleansing agent. Get medical attention if symptoms are severe or persist after washing.

**Protection of first aiders** It may be dangerous for first aid personnel to carry out mouth-to-mouth resuscitation.

### **4.2. Most important symptoms and effects, both acute and delayed**

**General information** The severity of the symptoms described will vary dependent on the concentration and the length of exposure.

**Inhalation** May cause sensitisation or allergic reactions in sensitive individuals.

**Ingestion** May cause sensitisation or allergic reactions in sensitive individuals. May cause stomach pain or vomiting. May cause severe internal injury.

**Skin contact** May cause skin sensitisation or allergic reactions in sensitive individuals. Prolonged contact may cause dryness of the skin.

### **5.3. Advice for firefighters**

**Protective actions during firefighting** Avoid breathing fire gases or vapours. Evacuate area. Cool containers exposed to heat with water spray and remove them from the fire area if it can be done without risk. Cool containers exposed to flames with water until well after the fire is out. Avoid discharge to the aquatic environment. Control run-off water by containing and keeping it out of sewers and watercourses. If risk of water pollution occurs, notify appropriate authorities.

### Eye/face protection

Unless the assessment indicates a higher degree of protection is required, the following protection should be worn: Tight-fitting safety glasses.

### Hand protection

It is recommended that chemical-resistant, impervious gloves are worn. The most suitable glove should be chosen in consultation with the glove supplier/manufacturer, who can provide information about the breakthrough time of the glove material. To protect hands from chemicals, gloves should comply with European Standard EN374. Considering the data specified by the glove manufacturer, check during use that the gloves are retaining their protective properties and change them as soon as any deterioration is detected.
