SECTION 5: Firefighting measures

5.1. Extinguishing media

7.1. Precautions for safe handling

Usage precautions

Keep container tightly sealed when not in use. Suspected of damaging fertility. Suspected of damaging the unborn child. Appropriate engineering controls

Provide adequate general and local exhaust ventilation. Ensure the ventilation system is regularly maintained and tested. Good general ventilation should be adequate to control worker exposure to airborne contaminants. Observe any occupational exposure limits for the product or ingredients.

Eye/face protection

Wear tight-fitting, chemical splash goggles or face shield. If inhalation hazards exist, a full-face respirator may be required instead.
