4.1. Description of first aid measures

SECTION 5: Firefighting measures

5.1. Extinguishing media

5.3. Advice for firefighters

Protective actions during firefighting Avoid breathing fire gases or vapours. Evacuate area. It is recommended that chemical-resistant, impervious gloves are worn.
