#### 7.1. Precautions for safe handling

##### Usage precautions

Read and follow manufacturer's recommendations. Wear protective clothing as described in Section 8 of this safety data sheet. Keep away from food, drink and animal feeding stuffs. Keep container tightly sealed when not in use. May damage fertility. May damage the unborn child. Pregnant or breastfeeding women should not work with this product if there is any risk of exposure.
