## SECTION 4: First aid measures

### 4.1. Description of first aid measures

<b>General information</b>	Get medical attention if any discomfort continues. Show this Safety Data Sheet to the medical personnel.

## SECTION 5: Firefighting measures

### 5.1. Extinguishing media

### 5.3. Advice for firefighters

**Protective actions during firefighting** Avoid breathing fire gases or vapours. Evacuate area. Keep upwind to avoid inhalation of gases, vapours, fumes and smoke.
