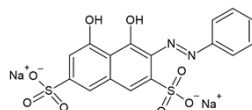

SECTION 4: First aid measures

4.1. Description of first aid measures

4.2. Most important symptoms and effects, both acute and delayed

Symptoms/effects : Not expected to present a significant hazard under anticipated conditions of normal use.

Symptoms/effects after inhalation : Dust of the product, if present, may cause respiratory irritation after an excessive inhalation exposure. May cause irritation to the respiratory tract, sneezing, coughing, burning sensation of throat with constricting sensation of the larynx and difficulty in breathing. Headache. More severe symptoms are also possible.

Symptoms/effects after skin contact : Dust may cause irritation in skin folds or by contact in combination with tight clothing. May cause skin irritation. Redness, pain. More severe symptoms are also possible.

Symptoms/effects after eye contact : May cause eye irritation. redness, itching, tears. May cause severe irritation. Blurred vision.

Symptoms/effects after ingestion : May cause irritation to the digestive tract. Abdominal pain, nausea. Swallowing a small quantity of this material will result in serious health hazard. Symptoms of ingestion include drowsiness, weakness, headache, dizziness, nausea, vomiting. More severe symptoms are also possible.

4.3. Indication of any immediate medical attention and special treatment needed

Treat symptomatically. Immediately call a POISON CENTER/doctor.

SECTION 5: Firefighting measures

5.1. Extinguishing media

Suitable extinguishing media : Foam. Dry powder. Carbon dioxide. Water spray. Sand.

SECTION 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

General measures : Isolate from fire, if possible, without unnecessary risk. Avoid dust formation. No flames, no sparks. Eliminate all sources of ignition.

6.1.1. For non-emergency personnel

Protective equipment : Wear recommended personal protective equipment.
