4.1. Description of first aid measures

4.2. Most important symptoms and effects, both acute and delayed

Symptoms/effects after inhalation : Toxic if inhaled. Symptoms may include dizziness, headache, nausea and loss of coordination. May cause circulatory shock, respiratory depression and convulsions.

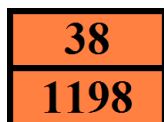
