## SECTION 4: First aid measures

### 4.1. Description of first aid measures

<b>General information</b>	Get medical attention if any discomfort continues. Show this Safety Data Sheet to the medical personnel.
<b>Inhalation</b>	Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Loosen tight clothing such as collar, tie or belt. Get medical attention if symptoms are severe or persist.

### **4.2. Most important symptoms and effects, both acute and delayed**

**General information** The severity of the symptoms described will vary dependent on the concentration and the length of exposure.

**Inhalation** A single exposure may cause the following adverse effects: Temporary irritation.

**Ingestion** May cause stomach pain or vomiting. May cause severe internal injury.

**Skin contact** Redness. Irritating to skin.

**Eye contact** Irritating to eyes.

### **5.1. Extinguishing media**

### **5.3. Advice for firefighters**

#### Appropriate engineering controls
