## SECTION 4: First aid measures

### 4.1. Description of first aid measures

<b>General information</b>	Get medical attention if any discomfort continues. Show this Safety Data Sheet to the medical personnel.
<b>Inhalation</b>	Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. Loosen tight clothing such as collar, tie or belt. ## SECTION 5: Firefighting measures

### **5.1. Extinguishing media**

### **5.3. Advice for firefighters**

**Protective actions during firefighting** Avoid breathing fire gases or vapours. Evacuate area. #### 7.1. Precautions for safe handling

**Usage precautions** Read and follow manufacturer's recommendations. Wear protective clothing as described in Section 8 of this safety data sheet. Keep away from food, drink and animal feeding stuffs. Keep container tightly sealed when not in use. Do not handle until all safety precautions have been read and understood. **Appropriate engineering controls** Provide adequate ventilation. Observe any occupational exposure limits for the product or ingredients.
