SECTION 4: First aid measures

4.1. Description of first aid measures

First-aid measures general : If possible show this sheet, if not available show packaging or label. Never give anything by mouth to an unconscious person. Do not leave affected person unattended.

SECTION 5: Firefighting measures

5.1. Extinguishing media
