4.1. Description of first aid measures

General information	Get medical attention if any discomfort continues. Show this Safety Data Sheet to the medical personnel. Chemical burns must be treated by a physician.

5.3. Advice for firefighters

Appropriate engineering controls

Use process enclosures, local exhaust ventilation or other engineering controls as the primary means to minimise worker exposure. Ensure the ventilation system is regularly maintained and tested. In case of insufficient ventilation, wear suitable respiratory equipment. Observe any occupational exposure limits for the product or ingredients.

Eye/face protection

Wear tight-fitting, chemical splash goggles or face shield. If inhalation hazards exist, a full-face respirator may be required instead.

Hand protection

Wear protective gloves. The most suitable glove should be chosen in consultation with the glove supplier/manufacturer, who can provide information about the breakthrough time of the glove material. To protect hands from chemicals, wear gloves that are proven to be impervious to the chemical and resist degradation.
