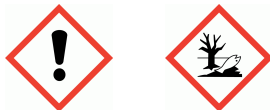

SECTION 5: Firefighting measures

5.1. Extinguishing media

1-Bromonaphthalene

Suitable extinguishing media Extinguish with alcohol-resistant foam, carbon dioxide, dry powder or water fog. Use fire-extinguishing media suitable for the surrounding fire.

5.2. Special hazards arising from the substance or mixture

Specific hazards Containers can burst violently or explode when heated, due to excessive pressure build-up.

Hazardous combustion products Vapours are heavier than air and may travel along the floor and accumulate in the bottom of containers. Thermal decomposition or combustion products may include the following substances: Harmful gases or vapours. Oxides of carbon. Hydrogen bromide (HBr).

5.3. Advice for firefighters

Protective actions during firefighting Avoid breathing fire gases or vapours. Evacuate area. Cool containers exposed to heat with water spray and remove them from the fire area if it can be done without risk. Cool containers exposed to flames with water until well after the fire is out. If a leak or spill has not ignited, use water spray to disperse vapours and protect men stopping the leak. Avoid discharge to the aquatic environment.
